



REGULATIONS ON THE CARRIAGE OF DANGEROUS SUBSTANCES AND ARTICLES

DHL Parcel Connect

1. General Information / Scope

These regulations apply to international shipping of dangerous goods in DHL Parcel Connect.

The following names and classifications correspond to the "European Agreement concerning the International Carriage of Dangerous Goods by Road" (ADR).

Unless otherwise stated, the following apply:

- The "European Agreement concerning the International Carriage of Dangerous Goods by Road" (ADR).
- Applicable national dangerous goods laws and regulations for dangerous goods.

2. Accepted substances and articles

The Product Parcel Connect accepts dangerous substances and articles, which can avail themselves of the following exemptions according to ADR (1.1.3.1 b), 1.1.3.2 f) & g), 1.1.3.10 b) & d) as well as 1.1.3.4):

- Dangerous goods released by Special Provisions (ADR Chapter 3.3).
- Dangerous goods packed in limited quantities (ADR Chapter 3.4).

3. Forbidden substances and articles

The following substances and articles are excluded from carriage:

- Substances and articles in which additional conditions to the special provision of Chapter 3.3 ADR are to be complied with, other than concentrations or

quantitative restrictions for each inner packaging. In particular, dangerous goods using Special Provision 168, 1st sentence, 201, 225, 226, 271, 283, 289, 319, 327, 363 b) remark 2 and g) (iv) - (vi), 364, 373, 375, 376, 377, 379, 382 (2nd and 3rd sentence), 565, 593, 636, 645, 650, 658, 663 and 667 are not accepted.

- Class 1 - Explosives (incl. UN0012, UN0014, UN0055)
- Division 2.3 - Toxic gases
- Division 6.2 - Infectious substances (incl. UN3373)
- Class 7 - Radioactive material
- UN1845 - Carbon Dioxide, solid (Dry Ice) also when used as a coolant
- UN2794 - Batteries, wet, filled with acid, electric storage (incl. SP 598)
- UN2795 - Batteries, wet, filled with alkali, electric storage (incl. SP 598)
- Dangerous goods packed in excepted quantities (ADR Chapter 3.5).

Shrink-wrapped or stretch-wrapped trays are not acceptable as outer packagings.

The carriage of international shipments with LQ and LiBa requires the signing of an annex to the contract regulating the international shipments. The the annex is available after contact with a DHL sales representative
